TERMS & CONDITIONS OF ENROLMENT

In accepting an offer of a place in the College you will become bound by the following terms and conditions upon which all offers of enrolment in the College are made:

- 1 Parents/Guardians must support and abide by the Aims, Policies and Rules of the College and ensure, to the best of their ability, that their children support and abide by those Aims, Policies and Rules.
- 2 Failure by a parent/guardian or student to support the Aims or abide by the Policies and Rules of the College may result in the student's enrolment being terminated.
- 3 In the event of improper, disorderly or reckless conduct or an act damaging to the reputation of the College by the student or a parent/guardian of the student, the College may at its discretion terminate the enrolment of the student.
- 4 Parents/Guardians must ensure that the fees, loans and other charges payable from time to time are paid within the terms specified for payment.
- 5 Fees and charges are annual fees and charges payable in full in February of each year. However, for the convenience of parents, fees and charges may be paid in three instalments in February, in May and in August of each year with invoices issued three times a year accordingly.
- 6 The College may, at its discretion, vary the rate of fee and loan and impose any other charge at any time as it considers necessary to ensure the continued economic viability of the College. As much prior notice as is possible will be given of any such increase or variation.
- 7 In the absence of a prior agreement, a late fee of \$55 (includes GST) will be charged on overdue accounts. The overdue fee will also apply where (if applicable) direct debit arrangements fail on three consecutive occasions.
- 8 The College reserves the right to terminate the enrolment of the student, in the event that an instalment is not paid by the due date.
- 9 In the event of the withdrawal of a student from the College, in the absence of a prior agreement, a full term's written notice must be given, otherwise an additional fee equivalent to one quarter of the annual tuition fee will be charged in lieu of notice.
